

Terms and conditions of participation for the EuroBean Chocolate Festival 05th - 07th August 2022

4. Exhibitor information

5. The costs for the booth space can be found in the exhibitor contract.

6. Exhibitors will receive a countersigned contract and an invoice for the booth space fees due after return of the signed exhibition contract. With the countersigned contract, the organizer confirms the participation of the exhibitor. Without this confirmation, the organizer cannot and will not provide the stand for which the exhibitor has registered. The invoice amount is to be paid at least two weeks before the start of the event.

7. Exhibitors need to register before setting up their booths. The contact will be published on the website. For further information see 4., information for exhibitors.

8. Exhibitors receive their exhibitor passes directly on-site. For further information see 4., information for Exhibitors.

9. Instructions of the organizing team and their representatives must always be followed.

10. The exhibition space will be assigned to the exhibitor by the host and shall be mandatory.

11. The periods for setting up and dismantling the exhibition booths as well as the period of exhibition must be adhered to as mentioned in the exhibitor contract. The booths must be engaged and ready to sell and provide information during those periods. In case of attrition of a booth the exhibitor undertakes to pay a fee of €200 per day as loss compensation. Cancellations are permitted in particular exceptional cases only and must be notified to the host indicating the reasons by Monday, 25th June 2022 at the latest. A refund of already paid charges is not possible.

12. Liability

- 1) The host assumes no liability for personal injuries and material damages that occur during the setting up and dismantling of the exhibition booths as well as for any damages, losses and contaminations of the exhibition booths and their contents during the time of the festival. Thus the exhibitor must care for his or her exhibition booth, its proper condition and all valuables inside by his-/herself. The host shall be liable according to the legal regulations, if he or one of his representatives or agents violates any essential obligation, whose implementation render the execution of the contract possible in the first place and to whose compliance the exhibitor may always rely on
- 2) In case of violations to the obligations other than mentioned in para. 1, the host shall be liable for himself and his representatives or agents only because of intention or culpable negligence, unless it deals with damages arising from loss of life, bodily injury or damage to the health of a person.
- 3) The liability of the host is limited to the damage predictable, if an essential obligation of the contract is being violated through negligence according to para. 1.
- 4) As far as liability is limited or excluded to the host this applies to personal liability for damages of employees, staff members, representatives and agents as well.

13. The exhibitor cares about the technical conditions of electronic devices and their electric connection by his-/herself. Setting up radiant warmers or electric heating is forbidden due to fire protection regulations.

14. The exhibitors are asked to independently obtain any official permits necessary for their sales as well as to adhere to any legal requirements and regulations.

15. Exhibitors are required to independently obtain all official permits necessary for their exhibitor offer and to comply with all legal regulations and statutory provisions.

16. Official requirements are part of these conditions of participation.
